

# LONG TERM VISA (RESIDENCE PERMIT) APPLICATION (LONG TERM STAY, MORE THAN 90 DAYS PERIOD)

## Residence permit for FAMILY REUNIFICATION

### Your application can be accepted only if you submit the following documents:

- Filled and signed application form for residence permit and Appendix 2 – find it on the website of Immigration and Asylum Office of Hungary.

- Valid passport with the previous (old) passports (at least 2 empty pages in the valid passport are needed!)
- 2 passport photos
- Flight booking
- Accommodation proof (lease agreement, acceptance letter from lessor or property registration sheet of your family member in Hungary)
- Valid travel insurance or proof, that you will be insured in Hungary
- Bank statement (of your sponsor) about the last 6 months, counting from the date of your interview
- Proof of income (of your sponsor)
- Proof of family relations (FRC, Birth Certificate, Marriage Registration Certificate or Tazkera in English for Afghan nationals)
- Original Nikah Nama if its applicable
- Clear character certificate issued by competent police department
- Medical examination certificate, with particular emphasis on:
  - Negative test certificate for HIV and Hepatitis b and c
  - Lung screening results
  - Certificate of absence of serious chronic and/or acute diseases
- Police report about lost passport, if any
- **We accept only original documents!**

**A residence permit for the purpose of family reunification may not be granted to a third-country national if the inviting family member:**

- **does not hold a residence permit for the purpose of guest self-employment for at least a year,**
- **holds a residence permit for the purpose of seasonal employment,**
- **holds a residence permit for the purpose of employment for the purpose of investment,**
- **holds a residence permit for the purpose of employment,**
- **holds a residence permit for guest workers,**
- **is a holder of a White Card,**
- **holds a residence permit for the purpose of studies, training,**
- **holds a residence permit for the purpose of traineeship,**
- **holds a residence permit for the purpose of voluntary service.**

**A visa is only a preliminary permission for entry, which does not authorize its bearer automatically to enter the country. The traveller may be requested to provide proof of the existence of the conditions of his/her entry and stay in Hungary and, if he/she is not able to fulfil this, he/she may be returned from the border.**
